Big Changes Starting June 1st

Beginning June 1, 2022 and ending May 31, 2023, Warren County-Vicksburg Public Library will be waiving late fines on our materials. In addition, we will forgive all existing late fines on library accounts. This will affect materials that have been returned to us in good condition,

Wearing Masks Is Now By Patron Discretion



Patrons/guests making use of the library may wear a mask at their discretion. We still request that anyone who has been recently exposed to someone who has tested positive for any of the COVID variants or who is running a fever (or displaying any other signs of illness regardless of the cause) please refrain from using the public areas of the library until they are past their quarantine period or feeling well again to protect their fellow patrons and the children who make use of our facilities.

We ask that patrons continue to respect their fellow patrons if they prefer to continue wearing masks and to social distance from others. Please remember that vaccinations are still not an option for our youngest patrons.

Also please keep in mind that if infection rates rise again, we may return to our previous restrictions.

As a reminder:

For patrons who have mobility issues or that currently wish to continue to avoid excessive public contact, we are continuing to provide curbside service. Patrons requiring curbside assistance might experience some wait times depending on current traffic inside the library and the availability of staff members.
